2021 State Tax Information

California Residents: Any distributions earned on bonds issued by a state other than California are reported to the California Franchise Tax Board, pursuant to California Revenue and Taxation Code Section 18639.

Puerto Rican securities: Income earned from Puerto Rican securities are fully exempt from federal regular income tax and may be exempt from state and local taxes.

Percentage of Income Earned by State

Some states may exempt from tax the portion of dividends generated by its own municipal obligations. Because of this, a percentage of your dividends may be exempt from state or local taxes. The table below shows the percentage of exempt-interest dividends derived from each state or territory.

State tax laws vary, please consult your tax advisor to determine if your state allows this exemption.
