Each share of Wilmington Maryland Municipal Bond Fund - Class A shares (CUSIP: 97181C548, Ticker: ARMRX) was exchanged for 0.750000 shares of Wilmington Municipal Bond Fund - Class A shares (CUSIP: 97181C464, Ticker: WTABX).

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ Each shareholder's aggregate basis in the shares of Wilmington Municipal Bond Fund they received in the exchange will equal their aggregate basis in the shares of Wilmington Maryland Municipal Bond Fund they surrendered.

The basis of each Wilmington Municipal Bond Fund - Class A shares received is equal to 133.3333% of the basis of each Wilmington Maryland Municipal Bond Fund - Class A shares surrendered.




