**RE: APRIL 2, 2015 PLAN DISTRIBUTION TO SENIOR NOTEHOLDERS**

**NO ACTION IS REQUIRED BY SENIOR NOTEHOLDERS**

**GENERAL BACKGROUND**

Wilmington Trust Company (the “Trustee”) is successor indenture trustee under that certain indenture dated as of September 1, 1987, as amended, supplemented or modified (the “Indenture”), between Lehman Brothers Holdings Inc. (formerly known as Shearson Lehman Brothers Holdings Inc.) (“LBHI”) and Wilmington Trust Company (as successor trustee to Citibank, N.A. (the “Predecessor Trustee”). Under the Indenture, LBHI issued certain senior debt securities (the “Senior Notes”). Each such Senior Note is identified by a unique alphanumeric sequence known as a “CUSIP number.” Holders of the Senior Notes are referred to herein as the “Senior Noteholders.”

On September 15, 2008, and at various times thereafter, LBHI and certain of its affiliates commenced cases under chapter 11 of the United States Bankruptcy Code (the “Bankruptcy Cases”). LBHI and its affiliates that filed bankruptcy proceedings in the United States are referred to herein as the “Debtors.”

A summary of facts relating to confirmation of the Debtors’ plan and previous distributions to the Senior Noteholders follows. Senior Noteholders may also refer to the previous notices issued by the Trustee, which are available on the website maintained by the Trustee at [www.wilmingtontrust.com/lehman](http://www.wilmingtontrust.com/lehman).

**CONFIRMATION OF DEBTORS’ PLAN**

On December 6, 2011, the Bankruptcy Court entered an Order [docket no. 23023 at [www.lehman-docket.com](http://www.lehman-docket.com)] confirming the Debtors’ Modified Third Amended Joint Chapter 11 Plan (the “Plan”) [docket no. 22973 at [www.lehman-docket.com](http://www.lehman-docket.com)]. The Senior Noteholder Claim is classified as a “Class 3” claim consisting of “Senior Unsecured Claims against LBHI.” On March 6, 2012, the Plan was deemed effective by the Debtors.

In connection with the effectiveness of the Plan, the original CUSIP number for each Senior Note was replaced by a corresponding “replacement CUSIP.” The original CUSIP number and corresponding replacement CUSIP number for each Senior Note are listed on Exhibit A.

**PREVIOUS PLAN DISTRIBUTIONS TO SENIOR NOTEHOLDERS**

On April 17, 2012, the Debtors made an initial distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Initial Plan Distribution”), as described more fully in the Notice from the Trustee dated April 11, 2012

(the “Initial Distribution Notice”).<sup>1</sup> The aggregate amount of the Initial Plan Distribution, after exercise of the Trustee’s charging lien, was \$2,925,499,812.23.

On October 1, 2012, the Debtors made a second distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Second Plan Distribution”) as described more fully in the Notice from the Trustee dated September 25, 2012 (the “Second Distribution Notice”).<sup>2</sup> The aggregate amount of the Second Plan Distribution to Senior Noteholders under the Plan, after exercise of the Trustee’s charging lien, was \$1,870,646,629.44.

On April 4, 2013, the Debtors made a third distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Third Plan Distribution”) as described more fully in the Notice from the Trustee dated March 27, 2013. The amount of the Third Plan Distribution to Senior Noteholders under the Plan was \$2,431,124,392.59.

On October 3, 2013, the Debtors made a fourth distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Fourth Plan Distribution”) as described more fully in the Notice from the Trustee dated September 26, 2013. The amount of the Fourth Plan Distribution to Senior Noteholders under the Plan was \$2,806,471,446.56.

On April 3, 2014, the Debtors made a fifth distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Fifth Plan Distribution”) as described more fully in the Notice from the Trustee dated April 2, 2014. The amount of the Fifth Plan Distribution to Senior Noteholders under the Plan was \$3,114,698,447.93.

On October 2, 2014, the Debtors made a sixth distribution of cash under the Plan to the Trustee on behalf of Senior Noteholders (the “Sixth Plan Distribution”) as described more fully in the Notice from the Trustee dated September 30, 2014 (the “Sixth Distribution Notice” and, collectively with the First Plan Distribution through the Fifth Plan Distribution, the “Previous Plan Distributions”).<sup>3</sup> The amount of the Sixth Plan Distribution to Senior Noteholders under the Plan, after exercise of the Trustee’s charging lien, was \$2,261,389,220.57.

The cumulative distributions to the Trustee on behalf of Senior Noteholders under the Previous Plan Distributions constitute 31.555706% of the total allowed amount of the Senior Noteholder Claim.<sup>4</sup>

### **SEVENTH PLAN DISTRIBUTION TO SENIOR NOTEHOLDERS**

As indicated in the Debtors’ Notice dated March 26, 2015 (the “Seventh Distribution Notice”),<sup>5</sup> on **April 2, 2015**, the Debtors will commence the seventh distribution under the Plan to the Trustee on behalf of the Senior Noteholders. The Seventh Distribution Notice states that the amount distributed will constitute **3.182633%** of the total allowed amount of the Senior Noteholder Claim. The calculation of the distribution to Senior Noteholders under the Plan results in an aggregate cash amount of \$1,555,119,895.63 (the “Seventh Plan Distribution”). After giving effect to the Seventh Plan Distribution, the cumulative distributions made by the Debtors to the Trustee on

<sup>1</sup> As described in the Initial Distribution Notice, pursuant to Section 607 of the Indenture, the Trustee asserted its charging lien for reimbursement of its reasonable fees and expenses (including attorneys’ fees and a reserve) in the amount of \$13,157,862.00 against the Initial Plan Distribution, which resulted in a pro rata reduction in the amount of cash payable to each Senior Notes CUSIP.

<sup>2</sup> As described in the Second Distribution Notice, the Trustee asserted its charging lien to replenish the reserve for reimbursement of its reasonable fees and expenses (including attorneys’ fees) in the amount of \$100,000.00 against such distribution.

<sup>3</sup> As described in the Sixth Distribution Notice, the Trustee again asserted its charging lien to replenish the reserve for reimbursement of its reasonable fees and expenses (including attorneys’ fees) in the amount of \$1,600,000.00 against such distribution.

<sup>4</sup> As more fully described in the Initial Distribution Notice, the Senior Noteholder Claim was allowed in the aggregate amount of \$48,783,940,671.72. The allowed amounts attributable to each Senior Note CUSIP number are set forth on Exhibit A.

behalf of the Senior Noteholders will constitute 34.738339% of the total allowed amount of the Senior Noteholder Claim.

Exhibit A reflects distribution amounts and distribution rates calculated according to embedded formulas for each Senior Note provided to Wilmington Trust by the Debtors. Exhibit A sets out for each Senior Notes CUSIP number, among other things, with respect to the Seventh Plan Distribution: (i) the aggregate distribution amount allocable to such CUSIP number; and (ii) the unrounded cash per \$1,000 principal amount or per unit of Senior Notes (the “Rate”) applicable to such CUSIP number.<sup>6</sup> Senior Noteholders may calculate the amount of their individual portion of the Seventh Plan Distribution as follows: (i) for those Senior Notes denominated in *dollar amounts* on Exhibit A, by dividing the principal amount of the Senior Notes that they hold by 1000 and multiplying the resulting number by the applicable Rate, or (ii) for those Senior Notes denominated in *units* on Exhibit A, multiplying the number of units of such Senior Notes that they hold by the applicable Rate.

A sample calculation of the individual distribution amount for each type of Senior Note is included below:<sup>7</sup>

1. For Senior Notes denominated in dollars:

Example: 10,000 principal amount (Senior Note CUSIP number 5252M0BZ9) / 1000 = 10  
10 x 32.079945 (CUSIP number 5252M0BZ9 Rate-last column)) = \$320.80 (amount of Seventh Plan Distribution)

2. For Senior Notes denominated in units:

Example: 100 Units (Senior Note CUSIP number 52522L558) =  
100 x 0.866621 (CUSIP number 52522L558 Rate-last column)) = \$86.66 (amount of Seventh Plan Distribution)

**NO ACTION IS REQUIRED BY SENIOR NOTEHOLDERS TO RECEIVE THEIR PORTION OF THE SEVENTH PLAN DISTRIBUTION. THE SEVENTH PLAN DISTRIBUTION WILL BE DEPOSITED IN THE ACCOUNTS IN WHICH SENIOR NOTEHOLDERS HOLD SENIOR NOTES. NO CHECKS WILL BE ISSUED.**

After the Seventh Plan Distribution, the Debtors will make distributions of available cash in accordance with the Plan semi-annually within five (5) business days of March 30 and within five (5) business days of September 30 of each year,<sup>8</sup> provided the aggregate distribution is not less than \$10,000,000. The Debtors have provided information regarding distributions under the “Distribution Information” tab of their website at [www.lehman-docket.com](http://www.lehman-docket.com).<sup>9</sup>

### **GENERAL INFORMATION**

The Trustee recommends that Senior Noteholders monitor the Debtors’ website ([www.lehman-docket.com](http://www.lehman-docket.com)) and the Trustee’s website ([www.wilmingtontrust.com/lehman](http://www.wilmingtontrust.com/lehman)) for information regarding the Bankruptcy Cases.

<sup>6</sup> For CUSIP numbers ending with three numerical digits (for example, 52522L350), Exhibit A refers to the number of “units” issued with respect to such security rather than dollar amounts of principal. Senior Noteholders holding these securities should refer to their broker or custodian statements to determine the number of units that they hold.

<sup>7</sup> The Trustee provides this sample calculation to assist Senior Noteholders in calculating the amount of their individual Seventh Plan Distribution. The Trustee cannot perform calculations on behalf of Senior Noteholders or respond to inquiries regarding individual calculations.
